- If scrip is deposited or withdrew through the Central Clearing, Client needs to fill in [Securities Settlement Instruction](#) form.

### **5. EIPO**

- Customer can subscribe IPO request through Internet or App trading platform without handling fee.



## **6. Clients Note**

- **DO NOT** accept trading instructions from unauthorized parties
- Our staff needs to confirm client's identity before trading
- Sufficient buying power is needed when trading
- **DO NOT** accept cash or third-party deposit
- Cut-off time for the deposit is **4:30 pm** on trading day in Hong Kong. If the notification is received after that, it will be processed on the next trading day
- Balance will be updated and used for trading only after the cheque is cleared
- Telegraphic transfer or express transfer may involve other bank charges, customer should check with the receiving bank on their own
- The withdrawal cut-off time is **12:00 pm** on the trading day, and notifications and instructions received after this time will be processed on the next trading day
- After receiving the withdrawal instruction, the company will deposit the money directly into the bank account designated by the customer at the time of account opening in the afternoon of the day with a crossed cheque
- If clients withdraw money by express transfer or telegraphic transfer, the company does not guarantee that the money can be transferred to the customer's designated bank account within the specified time.
- No. 8 typhoon signal takes effect on or before **10:00 am**, withdrawals and deposits will be processed on the next trading day
- The company's securities settlement deadline is **12:00 pm** on the trading day. Notices and instructions received after this time will be processed on the next trading day
- Physical stocks can only be traded within about 12 working days after confirmation by the account
- After withdrawing the physical stock, client needs to go to the registrar to go through the transfer procedure by themselves
- The deadline for IPO applications is **2:00 pm** on the trading day before the public deadline
- You must have sufficient buying power when apply the IPO
- The Shares can be traded on the day of listing
- Due to the improvement of the trading system, the company maintains it during non-trading hours from time to time. The online trading platform is temporarily unable to provide services.
